The Argor (from the French "Argent et Or", silver and gold) refinery was originally established in Chiasso, Switzerland in 1951 and was taken over by Union Bank of Switzerland (UBS) in 1973. A partnership was agreed in 1986 with Heraeus Holding Gmbh of Hanau. In 1999 UBS shares were taken over by Heraeus & Management. Later in 1999 Commerzbank International joined the shareholders, and in 2002, Austrian Mint also joined the shareholders. In 1988 the refinery moved from Chiasso to the new plant in Mendrisio.
