METALOR ACHIEVES RJC RE-CERTIFICATION FOR REFINING GROUP AND COC CERTIFICATION FOR SINGAPORE SUBSIDIARY

LONDON - The Responsible Jewellery Council (RJC) announced today that Metalor, the Swiss gold refiner, has achieved Re-Certification by meeting the highest ethical, social and environmental standards established by the RJC's Code of Practices (COP) Certification System.

Additionally, its subsidiary, Metalor Technologies (Singapore) has been certified against the RJC Chain of Custody (CoC) certification Standard. The CoC Standard supports responsible, conflict-sensitive sourcing in supply chains via a chain-of-custody through certified entities.

"RJC congratulates Metalor on achieving COP re-certification across its group and CoC Certification for Metalor Technologies (Singapore). After a Member has become RJC Certified for the first time, independent verification is required at the end of each certification period to ensure continued conformance and to maintain Certified Member status. CoC Certification provides a mechanism for refiners to demonstrate to downstream users how they are implementing the OECD Due Diligence Guidance for Responsible Supply Chains. Metalor's Singapore subsidiary joins their Swiss, USA, Hong Kong operations with their successful CoC Certification. The verification assessment was conducted by UL, one of the independent third-party auditing firms accredited by the RJC," says Catherine Sproule, RJC's Chief Executive Officer - Interim.

"Today, Metalor is extremely proud to have obtained the renewal of the RJC Certification, which has been established on the grounds of an independent audit, as well as the RJC - CoC certification. Also, further to this successful RJC-CoC certification of our new Singapore site, all Metalor refineries in the world comply with the very strict standards of ethical, social and environmental practices of the RJC.
