### **The Business**

Allgemeine Gold- und Silberscheideanstalt AG was founded in 1891 as a joint stock company in Pforzheim, at the hub of the German jewellery and watchmaking industry. For over a century the company has specialised in the recovery of precious metals and in manufacturing precious metal products. Allgemeine-group is represented in Europe and in Asia and has subsidiaries in Germany, Austria, the Netherlands, Thailand and China, and is part of the Umicore Group. In cooperation with its Umicore-partners within the Umicoregroup of companies, Allgemeine is also active in Great Britain, Italy and Canada.



### The Story

Allgemeine is the first German precious metals refinery to successfully complete the RJC certification process, and they were granted RJC Member Certification in January 2012. As a global company, they found that it is crucial to have the same standards and practices in all the business unit facilities over the world, thus facilitating processes and decisions considerably.
