The Business

Legor was incorporated in 1979. The spirit of its co-founder, the current Chairman Gianni Poliero, and the entry into the management of his son Massimo in 1991, grew the business from being a small, craft enterprise to a worldwide leader in the production and sale of master alloys for the gold and silver sectors.

Thereafter, activities were successfully dedicated to the galvanic sector, launching a complete line of solutions and technologically advanced machinery. From 2007, following the merger with the well-known brand, FOV Srl, the company from Vicenza became the Legor Group, a global supplier for the gold and silver industry.

The Story

In 1979 Gianni Poliero decided to assist a friend in his artisan production of master alloys dedicated to the jewellery industry, providing support for sales and analyzing market requirements. This pioneering business idea, together with genuine values and authentic principles, has set the success of the Legor Group throughout the years.

Legor Group S.p.A. achieved RJC Certification in March 2013. The multinational organisation believes it is crucial to have the same standards in all their global facilities. Technological know-how and high standards of specialization are seen as the distinguishing features of the corporation.
