PROVENANCE CLAIMS

Based on written assurance from our suppliers, these diamonds do not come from the Marange Region in Zimbabwe. Belfont SA states that the diamonds herein invoiced do not originate from Zimbabwe. Belfont SA has received similar written statements from its suppliers. All diamonds delivered are of natural origin. They have been 100 % checked in a synthetic diamond testing machine to ensure this. The diamonds mentioned in this invoice / delivery note are exclusively of natural origin and have not been treated. In case the invoice concerned GIA Certified diamonds, the following provenance claim is added: To assure the natural origin and the diamonds have not been treated, 100 % of the GIA certified diamonds have been verified by the GIA according to these two criteria. In case the invoice concerned non GIA Certified diamonds, the following provenance claim is added: To assure the natural origin, 100 % of the white non GIA certified diamonds are checked in a synthetic diamond testing machine to ensure this.
