

#### **JEWELRYARTS 24 -TERMS AND CONDITIONS**

Please read these Terms and Conditions carefully prior to your application to ensure you understand and agree to our rules of entry. To apply, you must agree with these terms and conditions and also agree that submission of any and all entries during the application process to the JewelryArts 24 Art Competition constitutes an agreement to these Terms and Conditions. These Terms and Conditions form a binding legal agreement between you and the Sponsor with respect to the JewelryArts 24 Art Competition. By entering the JewelryArts 24 Art Competition, you agree to comply with and abide by these Terms and Conditions and the selection methods employed by the judges, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept adjudicated decisions as final and binding as it relates to the content of this JewelryArts 24 Art Competition.

### **ELIGIBILITY**

To be eligible to enter the JewelryArts 24 Art Competition, an Applicant must: (a) be 18 years old as of the date of entry, (b) sign up via the official submission form on the JewelryArts 24 website.

The JewelryArts 24 Art Competition is open worldwide.

The JewelryArts 24 Art Competion is subject to the jurisdiction of England and Wales.

# **COMPETITION TIMELINES**

The JewelryArts 24 Art Competition submission opens at 9am BST on the 16th April 2024 and closes on 16<sup>th</sup> June 2024 (the "Art Competition Period"). Applications submitted before or after the Art Competition Period will not be eligible. All dates are subject to change. All applications must be submitted through the official form by the 16<sup>th</sup> June 2024 ("Submission Deadline") in order to be counted as valid for the JewelryArts 24 Art Competition.

On or after the 21<sup>st</sup> June 2024 the Judging Panel voting will take place to choose 1 winner. The winner will be revealed at an event during Frieze Week London, October 2024.

## **SPONSOR**

The Sponsor of the JewelryArts 24 Art Competition is the Responsible Jewellery Council (the Responsible Jewellery Council is the trading name of the Council for Responsible Jewellery Practices Ltd,) (RJC), Gemological Institute of America (GIA) and the Mineralogical & Gemological Museum of Harvard (MGMH) (together "the Sponsor"). The mission of JewelryArts 24 is to empower, artists, academics, scientists, industry and local communities



to unlock and understand the transition to green technologies in the jewelry industry and to take part in that transition through digital art.

#### **HOW TO APPLY**

Applicants are invited to apply for the JewelryArts 24 Competition by sending their artworks to the RJC via the RJC website and by submitting details of their application. Any applications that are incomplete or do not adhere to the rules or specifications of the JewelryArts 24 Art Competion may be disqualified at the absolute discretion of the Sponsor. You must provide the information requested and you may not apply more than once, use multiple email addresses, identities, or devices in an attempt to circumvent the rules. Any fraudulent methods or attempt to bypass or circumvent these terms and conditions of the Art Competition, will result in disqualification at the absolute discretion of the Sponsor.

### **ONE ENTRY PER APPLICANT**

In the case of a fraudulent or multiple applications on behalf of one individual, any and all subsequent applications may be disqualified. Machine or computer-generated mass applications will be disqualified. To be considered for the JewelryArts 24 Art Competition, applications must be: (i) completed online (as determined above); (li) received by the 16th June 2024 and (iii) in English. Any application not meeting the aforementioned criteria will be disqualified. The Sponsor accepts no responsibility for lost, delayed, damaged, defaced, or mislaid applications, however caused. Proof of submitting the form and an artwork does not constitute proof of applications. All applications will be deemed made by the Applicant submitted at the time of form completion.

### **JEWELRYARTS 24 REQUIREMENTS**

The Applicants and their applications to the JewelryArts 24 Art Competition must meet the following criteria ("JewelryArts 24 Requirements"):

- The Applicants must be 18 years of age at the time of submission.
- The Artworks must not be derogatory, offensive, threatening, defamatory, disparaging, libellous or contain any content that is inappropriate, indecent, sexual, profane, tortuous, slanderous, discriminatory in any way, or that promotes hatred or harm against any group or person or otherwise does not comply with the theme and spirit of the Art Competition.
- The Artworks must be original, unpublished and unminted works that do not contain, incorporate or otherwise use any content, material or element that is owned by a third party or entity. The applicant must be the originator and owner of the work.



- The Artworks cannot contain any content, element, or material that violates a third party's publicity, privacy or intellectual property rights.
- The Sponsor reserves the right, in its sole discretion, to disqualify any Applicant who submits the application and supporting statements which do not meet the JewelryArts 24 Requirements. Incomplete applications or applications not complying with these Terms and Conditions are subject to disqualification.

#### **RIGHTS AND WARRANTIES**

By applying for the JewelryArts 24 Art Competition and providing your original digital artwork (e.g., photo, video, animation, etc.), you understand and agree that the Sponsor and anyone else acting on behalf of the Sponsor shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the world, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the JewelryArts 24 Competition, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notices, review, or consent.

By applying for the JewelryArts 24 Art Competition, you represent and warrant that your entry is an original work of authorship and does not violate any third party's proprietary or intellectual property rights.

If your application and submitted artwork infringes upon the intellectual property right of another, you will be disqualified at the absolute discretion of the Sponsor.

If the content of your entry is claimed to constitute an infringement of any proprietary or intellectual proprietary rights of any third party, you shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless the Sponsor and all those acting on their behalf from and against any legal proceedings claims, liability, loss, damage, costs or expense, which the Sponsor or those acting on their behalf may incur, suffer, or be required to pay to arise out of such infringement or suspected infringement of any third party's right.

# **JUDGING**

The Competition artwork will be selected by JewelryArts 24 Judges and the Winner of the Competition will be notified via phone call and email. The winning Applicant will receive an email from jewelryarts24@responsiblejewellery.com



The Sponsor shall have no liability for a Winner's failure to receive notices due to spam, junk e-mail or other security settings or for a Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner cannot be contacted, is ineligible, fails to claim the prize within 2 (two) days from the time award notification was sent, the prize may be forfeited, and an alternate Winner selected.

Any violation of these official Terms and Conditions by the Winner at the Sponsor's absolute discretion will result in the Winner's disqualification as a Winner, and all privileges as winner will be immediately terminated.
