By Car:

It is recommended that those travelling by car use one of the many parking garages attached to the underground lines, and move around using public transportation.

By Train:

From the Central Station you can take the subway MM3 (yellow line) in the direction S. Donato and get off at Duomo.

From the Airport:

Malpensa airport is served by a rail link which runs every 30 minutes from Cadorna station / Northern Railway. The journey time is 40 minutes. Arriving at the Cadorna station you can take the underground MM1 (red line) and get off at Duomo.

From Linate airport recommend taking the shuttle bus to get to the Central Station, where you continue by underground line MM3 (yellow line) and get off at Duomo. Alternatively taxis are available.

Underground Lines:

Red Line MM1: the Duomo stop

Green line MM2: Cadorna stop, continue taking the MM1 (red line) to the Duomo

Yellow line MM3: the Duomo stop
