The Jewelry Company has synthetic diamonds testing technology and all the diamonds are checked in the testing machines for the surety of natural diamonds. The Jewelry Company, warrants that the gold, diamonds and silver have been supplied in compliance with the Signet Responsible Sourcing Protocols ("SRSPs").
